5. Match Review –

“Red” reported that at a meeting of the club officers held on January 17th, the match format for the following dates had been finalized:

- June 27th = Handgun/IDPA Night Match
- July 25th = .22 LR Only Match

I was reviewed that there would be three IDPA Only squads included in the mix of squads for all Handgun/IDPA Matches and that those squads would be held to strict IDPA rules. All other squads would be held to IDPA scoring requirements, specifically “Failure to Neutralize’ penalties, but would not be required to strictly hold to IDPA equipment requirements.

- Reconditioning of Existing Targets – Dueling Tree, Colt Poppers, etc. – Curtis Bullock
- Folding Tables used as stage tables (3 or 4)
